These Articles constitute the Articles of Incorporation of Setty Enterprises, Inc.

#### **Article I-Name**

The name of the Corporation is Setty Enterprises, Inc.

## Article II-Principal Office

The principal office of the corporation is 157 Windward Drive, Palm Beach Gardens, Fl 33418.

## Article III-Purposes for Which Corporation is Formed

The Corporation is organized for the purpose of transacting any and all business of which corporations may be formed under Chapter 607 of the Florida Statutes, as amended from time-to-time.

#### **Article IV-Duration**

The term of existence of the Corporation is perpetual.

## **Article V-Capitalization**

Unless otherwise expressly prohibited by

the Florida Business Corporation Act, and except as otherwise provided in the previous sentence, the Board of Directors of the Corporation shall have sole and exclusive discretion, on such terms and conditions as it shall determine, to indemnify, or advance costs to, any person made, or threatened to be made, a party to any action, suit or proceeding by reason of the fact that such person is or was an officer, employee or agent of the Corporation, as an officer, employee or agent of another Business Entity. No person falling within the purview of this paragraph may apply for indemnification or advancement of costs to any court of competent jurisdiction.

## Article VII-Bylaws

The Board of Directors and Shareholders may amend, repeal or adopt any Bylaw of and for the Corporation, but the Shareholders may prescribe that any Bylaw so amended, repealed or adopted by the Shareholders shall not be amended, repealed or adopted by the Board of Directors.
