ARTICLES OF INCORPORATION OF JOSEPH and BERNADETTE DIFRANCESCO, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation shall be: <u>JOSEPH and BERNADETTE DIFRANCESCO</u>, INC.

Article 2. Address. The address of the principal office of the Corporation is 2221 Springs Landing Blvd., Longwood, Florida 32779 and the mailing address of the Corporation is: 2221 Springs Landing Blvd., Longwood, Florida 32779.

Article 3. Authorized Shares. The Corporation is authorized to issue one class of shares, which shall be called common shares. Common shares shall have unlimited voting rights and shall be entitled to receive the net assets of the Corporation upon dissolution. The Corporation is authorized to issue 4,000 (four thousand) common shares.

Article 4. Initial Registered Office and Agent. The street address of the initial Registered Office of the Corporation is 2221 Springs Landing Blvd., Longwood, Florida 32779, and the name of the initial Registered Agent at that address is Joseph DiFrancesco.

Article 5. Incorporators. The name and address of the incorporators is as follows: Joseph and Bernadette DiFrancesco, 2221 Springs Landing Blvd., Longwood, Florida 32779.

Article 6. Restrictions Against Violation of S Status: a) The Corporation shall elect as an S Corporation under the Internal Revenue Code; b) The Corporation shall only authorize and issue one class of stock (voting or non-voting common); and c) No Stockholder shall do any act (including the sale or transfer of such Stockholder's stock) which shall contravene or revoke the Corporation's election to be taxed as an S Corporation.
