ARTICLE I - NAME

The name of this Corporation is TUTI'S SUPPLY INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on May 9, 2002.

ARTICLE III - PURPOSE

This Corporation may engage in any activity or business permitted
under the laws of the United States and of the State of Florida.






