OF

In compliance with the requirements of Chapters 607, Florida Statutes, the undersigned, being a natural person, hereby acts as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation:


ARTICLE IX

ARTICLE X


These Articles of Incorporation may be amended by any manner authorized by law at the time of amendment.
