OF

The ARTICLES OF INCORPORATION of REALISTIC SOFTWARE SOLUTIONS, INC., are as follows:

ARTICLE I.

The name of this corporation shall be REALISTIC SOFTWARE SOLUTIONS, INC.

The duration of this corporation is perpetual.

The aggregate of shares of stock of said corporation shall be 10,000 shares of common stock with a par value of \$1.00 per share.
