The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation.

ARTICLE I. NAME

The name of the corporation is Click Away, Inc.

ARTICLE II. PRINCIPAL OFFICE

ARTICLE III. CAPITAL STOCK


Pursuant to Chapter 48.901, Florida Statutes, the following is submitted:
