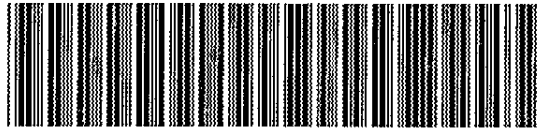


ARTICLE VII: DIRECTORS
