## ARTICLES OF INCORPORATION

**OF** 

Y.M.I., INC.

The undersigned, for the purpose of forming a corporation, adopts the following Articles of Incorporation:

### **ARTICLE I**

## NAME

The duration of the corporation is perpetual.
