ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Y.M.I., Inc., and its address is 2201 S.W. 87<sup>th</sup> Terrace, Davie, Florida 33324.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSES

The general purposes for which the corporation is organized are:

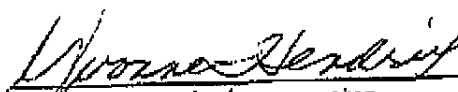
