The undersigned hereby forms a corporation under the following Charter or Articles of Corporation:

**ARTICLE I**

The name of the corporation shall be Applefield Waxman, Inc.

**ARTICLE II**

The principal office and mailing address of the Corporation is 5601 Corporate Way, Suite 404, West Palm Beach, Florida 33407.

**ARTICLE III**
