OF

I, the undersigned, who is a licensed real estate salesporson in the State of Florida, do hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida, these Articles of Incorporation for the purpose of forming a professional service corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be: Martha J. Pike, P.A.

ARTICLE II - PURPOSE

The purposes for which this corporation is formed are:

- A. To engage in the sale of real property as a professional corporation.

- C.
