Pursuant to the provisions of Section 607.0124 of the Florida Business Corporation Act, **ORIGINAL CREATORS USA, INC.** (the "Corporation"), Charter #P02000055425, adopts the following Articles of Correction:

1. Attached hereto as Exhibit A are Articles of Amendment of the Corporation filed on July 22, 2002 (the "Articles"), amending the Articles of Incorporation.
2. Paragraph 3 of the Articles misstated the new name that the Corporation has adopted.
3. Paragraph 3 of the Articles should be amended and restated in its entirety to read as follows:

**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
ROLE CITY INC.**

Pursuant to the provisions of Sections 607.1003, 607.1005 and 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is **ROLE CITY INC.** (the "Corporation").
2. The following Amendment to the Articles of Incorporation was adopted by the written consent of the sole director of the Corporation dated July 18, 2002, in the manner prescribed by Section 607.1003 of the Act. The Corporation having not yet issued shares, the sole director's consent is sufficient to effectuate the adoption of said Amendment by the Corporation, as provided by Section 607.1005 of the Act.
3. Article I of the Corporation's Articles of Incorporation is hereby deleted and replaced by a new Article I, as follows:

"ARTICLE I

The name of the corporation is **ORIGINAL CREATORS USA, INC.** (the "Corporation")."

4. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
5. The effective date of this amendment shall be upon the filing of these Articles of Amendment.
