

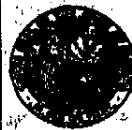

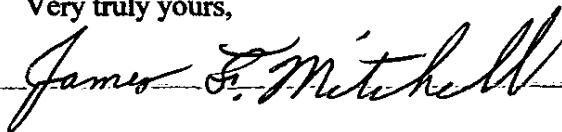
Gentlemen:
