I recently spoke to a colleague regarding our corporations and the UBR was brought up in our conversation. I am not sure if we have to file this year, since the corporations were started in 2002. We filed all of our tax returns on time and never received any notice from the State to report. We moved in December and it is possible that the mail never reached us.

For these reasons, if we do have to file, we are asking for an abatement of penalty for reasonable cause.
