ARTICLE OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is: <u>ISLA JOYERIA Jewelry, Inc.</u>

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purpose for which the corporation is organized is:

- 1. To engage in the business of Retail Store Jewelry Merchandize and Services.
