

# ARTICLES OF INCORPORATION OF ON-LINE-BUILDERS, INC.

The undersigned hereby organizes a corporation for profit under the provisions of the Florida Business Corporation Act, and pursuant to the following Articles of Incorporation.

#### ARTICLE 1

The name of this corporation is: ON-LINE-BUILDERS, INC.

#### ARTICLE 2 Mailing Address

The mailing and street address for the principal office of this corporation is: 101 West Flora Street, Tampa, Fl. 33604.

#### ARTICLE 3 Shares

This corporation is authorized to issue Seven Thousand Five Hundred (7,500) shares of One Dollar (\$1.00) par value common stock.

#### ARTICLE 4 Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 101 West Flora Street, Tampa, Fl. 33604, and the name of the initial registered agent of this corporation at that address is Jerome L. Spring.

#### ARTICLE 5 Incorporator

### ARTICLE 6 Initial Board of Directors

This corporation shall have two (2) directors initially. The number of directors may be either increased or diminished from time to time by the Bylaws, but shall never be less than one (1). The name and address of the initial directors of this corporation are:

The method of election of directors will be as stated in the Bylaws.

The corporation may enter into indemnification agreements and adopt Bylaw provisions for indemnification of any officer or director, or any former officer or director, or may provide, at the corporation's election, for indemnification of any officer or director, or any former officer or director, without agreement or Bylaw provisions to the full extent permitted by law. The corporation shall not be subject to court-ordered indemnification pursuant to Section 607.0850(9), Florida Statutes.
