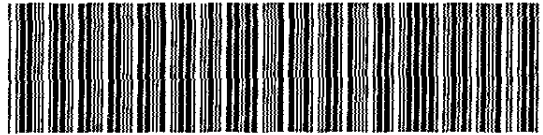

We understand that we have to file Articles of Dissolution. We never issued shares or commenced business under this name. We hope we have sent the necessary paperwork and payment for this dissolution.


Our enclosed check is for \$43.75. This would cover the filing fee of \$35 and we would also like one (1) certified copy of the dissolution for \$8.75.
