CERTIFICATE OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, for profit corporation, under the general laws of the State of Florida.

ARTICLE I. NAME
FASPORT ACCUMED SERVICES, INC.

ARTICLE II. ADDRESS

The initial post office of the principal office of the corporation in the State of Florida is as follows: **3901 W. Sunrise Blvd. Bay C-78, Lauderhill - Broward County Florida 33311**

However, the Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE III. NATURE OF BUSINESS

The general nature of the business and the objectives and purposes proposed to be transacted and carried on, are to do any and all of the things hereinafter mentioned, as fully as to the same extent that natural persons might, or could do, namely:

1. Providing portable X-ray services to the general public.
2. Provide other medical services as dictated by the need of the general public (to be implemented in the future).
3. Provide various types of X-ray services (to be implemented in the future).

ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred shares of common stock, with voting power with a par value of Ten Dollars (\$10.00) per share. The consideration to be paid for each share shall be fixed by the Board of Directors.

ARTICLE V. CAPITAL

The amount of capital with which this corporation will begin business is Fifteen Thousand dollars (\$15000.00) to be paid either in cash, merchandise, real estate, machinery or services in kind, as may be determined by the Board of Directors.

ARTICLE VI. TERMS OF EXISTENCE

The corporation is to exist perpetually.

ARTICLE VII. DIRECTORS

The corporation shall have two (2) directors, initially. The number of Directors may be increased or decreased from time to time, by by-laws adopted by the stockholders, but shall never be less than two (2).

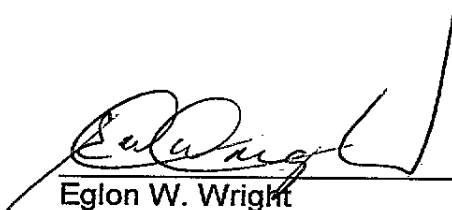

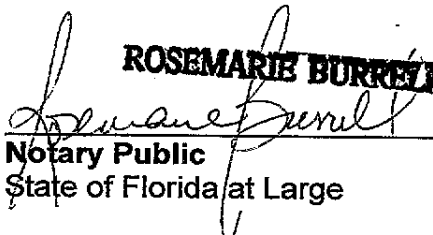

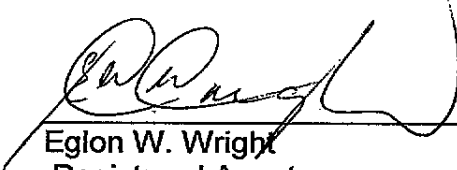
