- I, the undersigned, being a natural person of legal age, do hereby desire to form a Corporation under the Laws of the State of Florida, and do hereby adopt the following Articles of Incorporation.
- 1. **NAME.** The name of the Corporation shall be R. S. T. TECHNOLOGIES, INC., a Florida Corporation.
