

The name of this corporation is D'lisch, Inc.



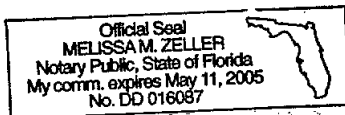
