

ARTICLE 1: CORPORATE NAME: The name of this corporation is Alberto's Studio One, Inc.

ARTICLE 2: PRINCIPAL OFFICE: The street address of the initial principal office of this corporation is 2735 East Oakland Park Boulevard, Fort Lauderdale, Florida 33306.




