ARTICLES OF INCORPORATION
OF
JAS CATTLE COMPANY

WE, the undersigned incorporators, hereby make, subscribe, acknowledge, and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of State of Florida.

ARTICLE I

The name of this corporation shall be:

JAS CATTLE COMPANY

ARTICLE II

The general nature of the business to be transacted by this corporation, or the objects or purposes of the corporation shall be as follows:

A. To engage in all activities relating to the raising or maintenance of animal livestock.

B. In general to carry on any other business in connection with the foregoing and to have and exercise all powers conferred with the foregoing in accordance with the laws of Florida upon corporations formed under the general corporation acts of the State of Florida and any amendments thereto.

The foregoing clauses shall be construed both as objects and powers; and it is hereby expressly provided that the foregoing enumeration of special powers shall not be held to limit or restrict in any manner the powers of this corporation.

ARTICLE III

A. The total number of shares of capital stock authorized to be issued by the corporation shall be 500 shares having a par value of \$1.00 per share. Each of the shares of stock shall entitle the holder thereof to one vote at any meeting of the stock holders. All or any part of said capital stock may be paid for in cash, in

property, or in labor or services at a fair valuation to be fixed by the Board of Directors at a meeting called for such purposes. All stock when issued shall be paid for and shall be non-assessable.

B. In the election of directors of this corporation there shall not be any preemptive or preferential right to subscribe to, purchase or receive any shares or class of stock.

ARTICLE IV

The amount of capital with which this corporation shall begin business will be the sum of \$500.00.

ARTICLE V

The existence of this corporation shall begin upon the filing with and approval by the Secretary of State of these Articles of Incorporation; and thereafter the existence of this corporation shall be perpetual.

ARTICLE VI

The principal office of this corporation shall be located at:

There shall be a Board of Directors for the Corporation which shall consist of not less than one and not more than three members which shall be fixed by the stockholders or By-Laws. Each director shall be over the age of 18 and a citizen of the United States. A quorum for the transaction of business shall be a majority of the directors present at the meeting. Meetings shall be held by the Board of Directors and members of the Board need not be stockholders. The stockholders of this corporation may remove any director from office at any time with or without cause.

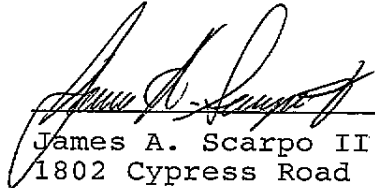
