ARTICLES OF INCORPORATION
OF
Marie A. Potopsingh, P.A.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby associates herself to form a professional association under the laws of the State of Florida.

ARTICLE I

NAME: The name of this professional association is:

MARIE A. POTOPSINGH, P.A.

ARTICLE II

PURPOSES AND POWERS: The general nature of business to be transacted by the professional association is as follows:

1. The professional association shall engage in the activity of conducting a law office of which is permitted under the laws of the State of Florida.
2. And in general, to carry on any other business whatsoever in connection with the foregoing which is calculated to promote the interest of the professional association or to enhance the value of its properties.
3. And, further, to borrow or raise money for any purposes of the professional association, and to secure the same interest, or for other purposes, to mortgage all or part of the property corporeal or incorporeal rights or franchise of this professional association now owned or hereinafter acquired, and to create, issue, draw and accept and negotiate bonds and mortgages, bills

ARTICLE III

CAPITALIZATION: The maximum number of shares of stock this professional association is authorized to have outstanding at any time is ONE HUNDRED (100) shares of common stock, having a par value of ONE AND 00/100 (\$1.00) DOLLAR per share.

ARTICLE IV

INITIAL CAPITAL: The amount of capital with which this professional association will begin business is ONE HUNDRED AND NO/100 (\$100.00) DOLLARS.

ARTICLE V

COMMENCEMENT AND DURATION: This professional association is to commence existence upon the filing of the Articles of Incorporation by the Department of State.

ARTICLE VI

PRINCIPAL PLACE OF BUSINESS: The name of this corporation shall be Marie A. Potopsingh, P.A. having its principal place of business at 9358 Northwest 47th Street, Sunrise, Florida 33351.

The Board of Directors may, from time to time, move the principal office to any other address in the State of Florida, and establish branch offices in any place within the State of Florida, as the said corporation may desire.

ARTICLE VII

DIRECTORS: This professional association shall have (1) director initially; the number of directors may be increased from time to time by the laws adopted by the stockholders, but shall never be less than one (1).

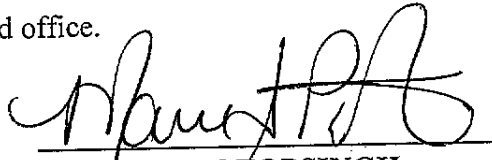

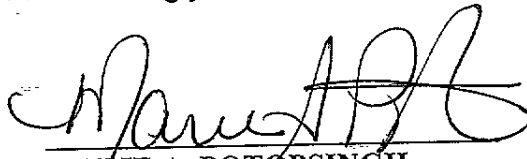

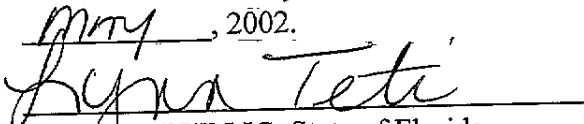
