The undersigned, for the purposes of forming a corporation under Section 607.0202 of the Florida Business Corporation Act, does hereby certify as follows:

ARTICLE I

Corporate Name and Address

The name of the Corporation is Western Management, Inc., and the street address of the Corporation is 399 Gulf Shore Boulevard South, Naples, Florida 34102.

ARTICLE II

Corporate Purposes

The Corporation is organized to transact any and all lawful business authorized by the Florida Business Corporation Act.

ARTICLE III

Authorized Stock

The aggregate number of shares of the Corporation shall be 10,000, all of which are to be voting common stock having a par value of Fifty Cents (\$.50) per share.

ARTICLE IV

Registered Office and Registered Agent

The street address of the initial registered office of the Corporation in the State of Florida shall be 5551 Ridgewood Drive, Suite 101, Naples, Florida 34108. The name of the initial registered agent of the Corporation at the registered office shall be Ronald L. Stetler.

The number of Directors may be increased or decreased from time to time in accordance with the By-laws, but shall never be less than one (1). Commencement of Existence

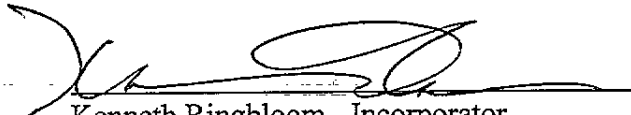
The Corporation shall be deemed to commence on the date of execution of Articles of Incorporation.

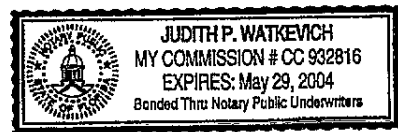
