ARTICLES OF INCORPORATION OF SOUTH PARK GROCERY, INC.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit, Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is **SOUTH PARK GROCERY, INC.**, hereinafter referred to as the "Corporation."

ARTICLE 2 - PURPOSE OF CORPORATION

The purpose of the Corporation is to transact any and all lawful business for which corporations may be incorporated under the laws of the United States and of the State of Florida, as they may be amended from time to time.

ARTICLE 3 - PRINCIPAL OFFICE

The principal office of the Corporation is 443-445 So. Park Avenue, Titusville, Florida 32780. The Corporation may maintain offices and/or transact business at other locations, either within or without the State of Florida.

rights conferred upon shareholders in these Articles of Incorporation or any amendment hereto are granted subject to the reservation.
