

ARTICLES OF INCORPORATION

OF

CONCEPTS IN COLOR PAINTING, INC.

I, the undersigned Incorporator, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopt Articles of Incorporation as follows:

ARTICLE I

The name of this Corporation is CONCEPTS IN COLOR PAINTING, INC. The principal place of business of this corporation shall be 800 North Lakemont, Suite 1, Winter Park, FL 32792.

ARTICLE II

This Corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is 100 shares of common stock having a par value of \$1.00 per share.


