Angela Maria Restrepo, the undersigned, being of the age of eighteen (18) years or more, does hereby make and acknowledge these Articles of Incorporation under and virtue of the laws of the State of Florida.

1. The name of the Corporation shall be: Sunblock Window Film Corp.
2. The number of shares the corporation is authorized to issue shall be 500 shares all of one class designated as common stock, at \$ 1.00 per value.
3. The street address and county of the initial principal office of the corporation is 9101 SW 122 Ave. Suite 105 Miami, Fl. 33186, Miami-Dade County and the name of the initial registered agent at this address is Angela Maria Restrepo, residing at 9101 SW 122 Ave., Suite 105. Miami, Fl. 33186.
4. The number of directors constituting the initial board of directors shall be two directors and the names and addresses of the persons whom are to serve as directors until the first meeting of shareholders or until their successors are elected and qualify are:
  - 1) Angela Maria Restrepo, President-Secretary, residing at 9101 SW 122 Ave., Suite 105 Miami, Fl. 33186 and
  - 2) Alberto Restrepo, Vice-President-Treasurer, residing at 9101 SW 122 Ave. Miami, Fl. 33186
5. To the fullest extent permitted by the State of Florida Business Corporation Act as it exists or may hereafter be amended, no person who is serving or who has served as a director of the corporation shall be personally liable to the corporation or any of its shareholders for monetary damages for breach of duty as a director. No amendment or repeal of this Article nor the adoption of any provision of these Articles of Incorporation inconsistent with this Article shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment, repeal, or adoption.
