**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
KOALATY PRODUCTS, INC.**

Pursuant to the Florida Business Corporation Act, KOALATY PRODUCTS, INC. (the "Corporation"), a corporation organized and existing under the Florida Business Corporation Act, does hereby certify and set forth as follows:

**FIRST:** The Corporation's name is: **KOALATY PRODUCTS, INC.**

**SECOND:** The Corporation was originally incorporated and the original Articles of Incorporation of the Corporation were filed with the Secretary of State of Florida on May 21, 2002, and assigned document number P02000056678.

**THIRD:** Resolutions were duly adopted by the Board of Directors of the Corporation setting forth a proposed amendment to the Articles of Incorporation of the Corporation and declaring such amendment to be advisable and in the best interests of the Corporation and its shareholders.

**FOURTH:** Article I of the Corporation's Articles of Incorporation is hereby amended in its entirety to read as follows:

**FIFTH:** Pursuant to the recommendation of the Board of Directors of the Corporation, the shareholders of the Corporation duly adopted and approved these Articles of Amendment to Articles of Incorporation by consenting thereto in writing in accordance with the Florida Business Corporation Act.
