ARTICLE II - CORPORATE POWERS: The Corporation is organized to conduct any and all business for which a corporation may be organized.


ARTICLE III - CAPITAL STOCK: The authorized capital stock of the Corporation shall be 5,000 shares of \$1.00 par value common stock.


