**ARTICLES OF INCORPORATION
OF**

The undersigned, for the purpose of forming a corporation, adopts the following
Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Tom "The Bomb", Inc. and its address is 15705 W.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSES

The general purposes for which the corporation is organized are:


