ARTICLES OF INCORPORATION OF ARDENT CONSTRUCTION, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following articles of incorporation.

ARTICLE ONE NAME

The name of the corporation is Ardent Construction, Inc.
