**ARTICLES OF INCORPORATION OF  
TubeUR, Inc.**

Pursuant to Chapter 607 of the Florida Statutes, the undersigned, desiring to form a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**Article I. Name**

The name of the Corporation is TubeUR, Inc.

**Article II. Corporate Offices; Mailing Address**

The principal office of the Corporation shall be located at and its mailing address shall be Post Office Box 547776, Orlando, Florida 32854.

**Article III. Purposes**

The Corporation is organized and shall be operated for all lawful purposes.

**Article IV. Directors**

The affairs of the Corporation shall be managed by a Board of Directors. The number and manner of election or appointment of Directors and their terms of office shall be as provided in the Bylaws.

**Article V. Bylaws**

The Board of Directors of the Corporation shall provide for the adoption of such Bylaws for the conduct of the Corporation and the carrying out of its purposes as the Board of Directors shall deem necessary.

**Article VI. Registered Agent**

The street office of the Corporation's registered office shall be 715 Vassar Street, Orlando, Florida 32804, and the name of the registered agent of the Corporation at such office shall be Christopher C. Skambis.

**Article VII. Shares of Stock**

The aggregate number of shares which the Corporation shall have authority to issue is ONE THOUSAND (1,000) shares of capital stock, with a value of \$1.00 each.


**Article VIII. Incorporator**

**Article IX. Effective Date**


The effective date of these Articles of Incorporation shall be May 22, 2002.
