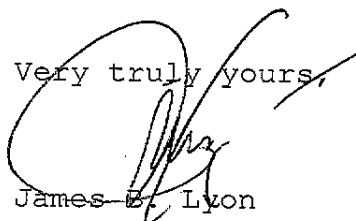

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

The name of this Corporation is BENA ENTERPRISES, INC.

ARTICLE II-PRINCIPAL OFFICE

The street address of the initial principal office and mailing address of this Corporation shall be: 1679 New Haven Point Lane, West Palm Beach, Florida 33411.

ARTICLE III-PURPOSE

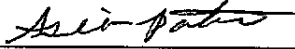
