ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of the corporation shall be THOMAS DE GEORGE LANDSCAPE MAINTENANCE, INC.

ARTICLE II NATURE OF BUSINESS

This corporation may engage in landscape maintenance and/or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock having a par value of \$1.00 per share.

ARTICLE IV ADDRESS

ARTICLE V SPECIAL PROVISIONS

This corporation shall commence its existence on June 1, 2002 and exist perpetually.

ARTICLE VII LIMITATION OF LIABILITY

The foregoing right of indemnification shall be inclusive of any other rights to which any director, stockholder or officer may be entitled as a matter of law.

Any director of the corporation may vote upon any transaction with the corporation without regard to the fact that he is also a director of such subsidiary or corporation.

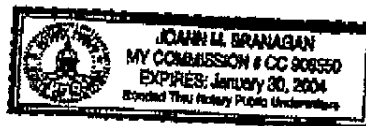
