ARTICLES OF INCORPORATION

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit pursuant to the Florida General Corporation Act, as particularly set forth in Chapter 607 of the <u>Florida Statutes</u>.

ARTICLE I - NAME

The name of the corporation is WI2 Investments, Inc.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in consulting, investments, venture capital transactions and other entrpreneurial transactions.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is one hundred (100) shares of common stock, each having the par value of \$1.00. The maximum number of shares shall be 5,000.

ARTICLE X - EFFECTIVE DATE

These Articles of Incorporation shall be effective and the corporation's existence shall begin when these Articles of Incorporation are received by the office of the Florida Secretary of State.

ARTICLE XI - VOTING RIGHTS

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding common shares.
