ARTICLE THREE SHARES

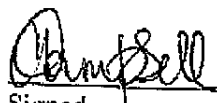

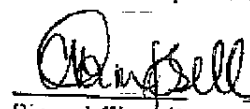

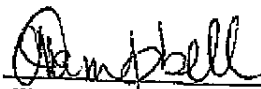
