**ARTICLES OF INCORPORATION
OF
T. J. POTTER DISTRIBUTING CORP.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is **T. J. Potter Distributing Corp.**

ARTICLE II

The existence of the corporation shall begin on May 23, 2002.

ARTICLE III

The street address and mailing address of the principal office of the Corporation is 2225 Nuremburg Boulevard, Punta Gorda, Florida 33983.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares.
