ARTICLE I

NAME

The name of the Corporation is MANN'S PAINTING, INC.

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III

PURPOSE
