I am writing this at the request of Margarita of the annual report division. I am requesting an abatement of the late filing penalties for not submitting the UBR in a timely fashion.

At the inception of the corporation – which I knew would not be active for some time – I was never told by my attorney/registered agent what taxes or required forms I was legally obligated to file and pay. Since the corporation was dormant, it never occurred to me to pursue this matter. Further, it was never suggested to me.

I never received – from the registered agent – the UBR and all other state and federal forms which I was required to file.
