In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is N Entertainment Group, Inc.

ARTICLE II

The principal place of business and mailing address of the Corporation is: 3415 West Hillsborough Avenue #731, Tampa, Florida 33614.

ARTICLE III

The Corporation is being incorporated for the purpose of conducting business that is legal for a Corporation to conduct in the State of Florida.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is ten thousand (10,000), all of which shall be Common Shares with par value of one cent (\$0.01) per share. All Common Shares shall be identical with each other in every respect and the holders of the Common Shares shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote.

The initial officers of the Corporation are as follows:

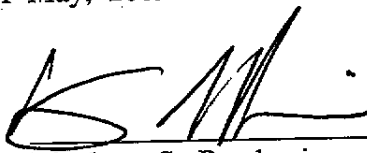

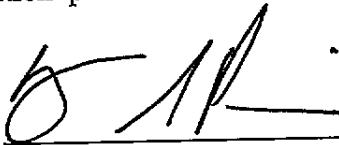
