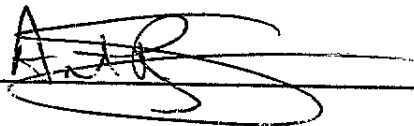

This Corporation elects to have preemptive rights.

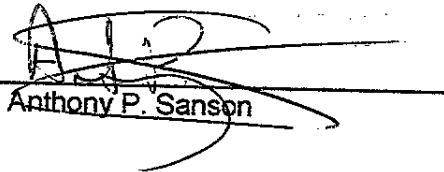
ARTICLES XIV-AMENDMENT

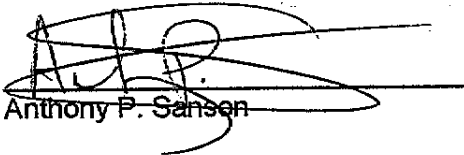

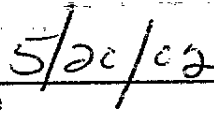
