ARTICLE I

The name of the corporation is Murray Boyz Entertainment, INC., (hereinafter called the "Corporation").

ARTICLE II

The Corporation is organized to engage in any and all activities in the area of entertainment, performing, promoting, management or any other activity relating to the entertainment industry, and to engage in such other activities as are necessary, appropriate, or convenient to the furtherance of the foregoing stated purposes and permitted under the laws of Florida and of the United States.

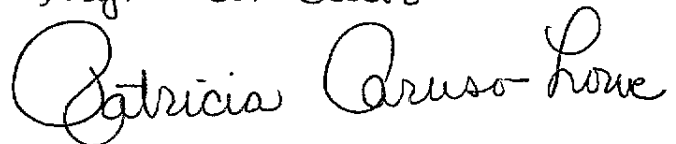

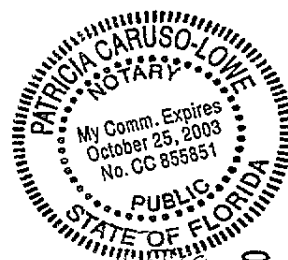
