#### ARTICLE I - NAME

The name of this corporation shall be THE PERFECT MATCH CUSTOM CLOTHIERS, INC.

#### ARTICLE II - PURPOSE

The Corporation may engage in any activity or business under the laws of the United States and the State of Florida's General Corporation Act.
