ARTICLES OF INCORPORATION

BACK PAIN INSTITUTE OF FLORIDA, INC.

The undersigned hereby forms a corporation for profit under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

BACK PAIN INSTITUTE OF FLORIDA, INC.

The address of the principal office of this corporation shall be 3000 Stirling Road, Hollywood, Florida 33021, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory, or nation.

ARTICLE III. CAPITAL STOCK

The corporation shall have authority to issue One Million (1,000,000) shares of Class A voting common stock, having a par value of One one-thousandth of a Cent (\$0.00001) each, and One Million (1,000,000) shares of Class B non-voting common stock, having a par value of One one-thousandth of a Cent (\$0.00001) each.

The shares of Class A voting common stock and of the Class B non-voting common stock, and the preferences, limitations, and relative rights thereof, shall be identical, except only that shares of the Class B non-voting common stock shall not have any voting rights, while all voting rights of the shareholders will be held by the shareholders owning the shares of the Class A voting common stock.

ARTICLE IV. REGISTERED AGENT

The street address of the initial registered office of this corporation shall be 3000 Stirling Road, Hollywood, Florida 33021, and the name of the initial registered agent of the corporation at that address is Dr. Ernest Baustein.

ARTICLE V. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI. OFFICERS AND DIRECTORS


