Each Shareholder shall have a preemptive right to purchase any treasury or unissued stock of the corporation pursuant to terms and conditions set by the Board of Directors.



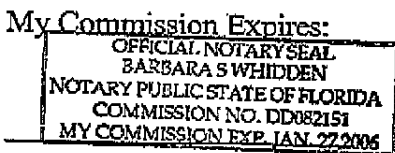


