THE UNDERSIGNED, being over the age of eighteen years, in order to form a corporation pursuant to the provisions of the Corporate Code, hereby certifies as follows:

Article I
Identification

The name of the corporation, hereinafter referred to as the "Corporation," is MD Dealers-Distributors Association, Inc.

Article II
Period of Existence

The period during which the corporation shall continue is perpetual.

Article III

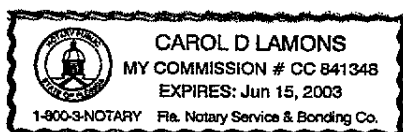
