The number of Directors of this Corporation shall be at least one(1) and no more than five.

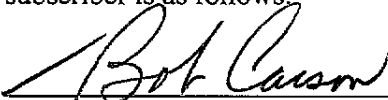
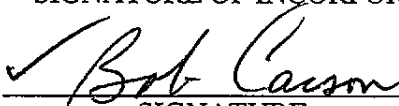
