The shareholders of the Corporation shall not have the preemptive rights provided by Section 302A.413 of the Minnesota Statutes to subscribe for and to purchase any or all of the shares or other securities, or rights to purchase shares or other securities, of the Corporation, now or hereafter authorized."; and

WHEREAS, said ARTICLE X., subd. a. should cite Section 607.0630 of the Florida Statutes.


NOW, THEREFORE, subd. a. of ARTICLE X. of the Articles has been corrected to read as follows:
