**ARTICLE I - NAME**

The name of this corporation is **SMITH COOPER & LIBERMAN ACCOUNTING AND TAX SERVICE, INC.**

**ARTICLE II - DURATION**

This corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States and of the State of Florida.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue **ONE THOUSAND (1,000)** shares of **\$1.00** par value, which shall be designated as "Common Stock".

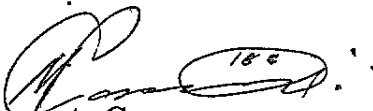

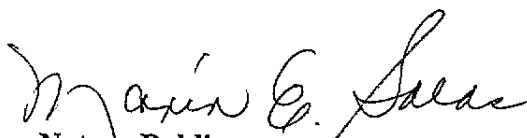

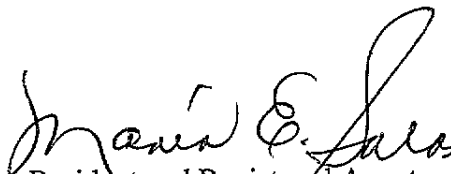
