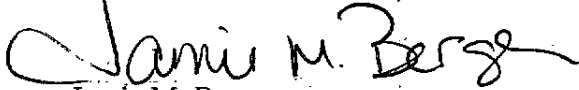

ARTICLES OF INCORPORATION
OF
QUALITY CARPET AND TILE CLEANERS, INC.

ARTICLE I

NAME, PRINCIPAL OFFICE, AND MAILING ADDRESS

The name of this corporation is Quality Carpet and Tile Cleaners, Inc. The corporation's initial principal office and mailing address are located at 4163 Phillips Highway, Jacksonville, FL 32207.

ARTICLE II

NATURE OF BUSINESS

This corporation is organized for the purpose of engaging in and transacting any or all lawful business permitted under the laws of the State of Florida or any other state and of the United States.

ARTICLE III

CAPITAL STOCK

This corporation is authorized to issue One Thousand (1000) shares of common stock having no par value, which shares shall be and hereby are designated as "Common Shares".

ARTICLE IV

TERM OF EXISTENCE

The term for which this corporation shall exist shall be perpetual, commencing on October 1, 1995.

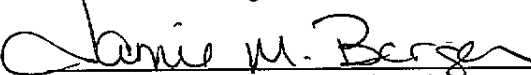

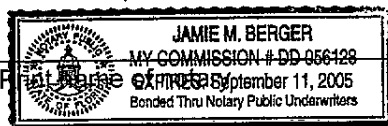
